I further acknowledge and understand that all balances must be paid by the third Wednesday of the month, or my student will be dropped from the program until balances are paid in full.

Hours used outside or beyond the selected option/tier listed above will be billed based on the difference between the contracted option/tier to the higher hour tier. If my student utilizes more hours than indicated based on their payment option/tier for two consecutive months, my student will automatically be placed in the next higher tier and I will be responsible for the higher hour tier for future payments. If I choose to cancel child care services at any time during the academic school year, a two-week written notice will be required.
